1. REQUEST FOR DISPENSATION

- 1.1 Councillor David Mossman has asked for a six month dispensation from attendance at meetings of the Authority for the reason that he is in a vulnerable high risk group due to undergoing regular treatment and so is currently unable to attend meetings at all or with any regularity.
- 1.2 Section 85 of the Local Government Act 1972 provides that, *“if a member of a local authority fails throughout a period of six consecutive months from the date of his last attendance to attend any meeting of the authority, he shall, unless the failure was due to some reason approved by the authority before the expiry of that period, cease to be a member of the authority.”*
- 1.3 Councillor Mossman last attended a meeting of the authority when he was present at the meeting of the Environment Committee on 9 September 2021. Section 85(2) of the 1972 Act deems attendance at a meeting of a committee or sub-committee or other council body to be attendance at a meeting of the authority.

- 1.4 Granting a dispensation does not preclude Councillor Mossman from attending a future meeting during that period should he feel able to do so.
