DATE OF LAST MEETING ATTENDED	30 March 2023
BRIEF REPORT:	
<p>As usual, the meeting began with a brief update from the Chair of the Gloucestershire Economic Growth Committee (“GEGC”), Cllr Tony Dale, on that Committee’s recent work. There was some discussion on the upcoming transition of GEGC into the City Region Board, and specifically around the charring of that new Board, with some differences of opinion as to how that should be managed and whether or not the county council should/could chair. It was confirmed that this Scrutiny committee will go on to scrutinise the work of the City Region Board once the transition has taken place.</p> <p>The remainder of the meeting, which was hosted at the offices of Cheltenham Borough Council, comprised an update on CBC SLT’s vision for economic growth in the Cheltenham area, and a specific update on the Golden Valley Development. Members had various questions on aspects of that development, including how it is expected to lift prosperity in the adjoining communities (examples were given of other developments that were being looked to for best practice on this), and overall the presentation was positively received. The Committee agreed to continue visiting district offices on rotation every other meeting, to hear and discuss the local vision for the economy.</p> <p>The Executive Director for Economy, Environment & Infrastructure’s report was taken as read but a wide range of detailed questions received in advance of the meeting were answered by officers or deferred for written response. Members were advised that discussions between county and the districts on the operation of the Community Infrastructure Levy across the county had taken a more positive turn since the last meeting, and good progress was being made in those districts where a mechanism to distribute CIL to infrastructure providers did not already exist.</p> <p>Meeting papers: https://glostext.gloucestershire.gov.uk/ieListDocuments.aspx?CId=731&MId=11204</p>

DATE OF LAST MEETING ATTENDED	29 March 2023 (Project Board Meeting)
BRIEF REPORT:	
<p>A Canal Project Update was provided for the S&R Committee Meeting in February 2023 and this briefing follows the latest Project Partners' Board Meeting, held on 29 March 2023.</p> <p>In the February update to S&R Committee, it was noted that: "The next NLHF review meeting is on 7th February 2023. We have submitted a bid for a further grant of £2.3 million from the NLHF Covid Fund; this is anticipated to be considered at the NLHF March Board meeting." It was agreed at the NLHF review meeting that we would defer the grant application until we had secured planning approval.</p> <p>Positive progress has been made on the planning application for 'the missing mile'. Flood modelling and all concerns raised by the Environment Agency have now been addressed. We are currently working on an updated Environmental Statement (incorporating Flood Risk Assessment) which will be re-circulated to the statutory consultees for comment and approval. As a result, we expect to secure approval from the statutory consultees in time for consideration by the Development Control Committee meeting on 12th September 2023.</p> <p>Volunteers from the Cotswold Canals Trust, Stroud Valleys Canal Company and Waterways Recovery Group continue to work on the restoration of the canal in Phase 1B. This work includes towpath maintenance and improvements, vegetation clearance, dredging and lock restoration. Volunteers from Gloucestershire Wildlife Trust and Stroud Valleys Project are continuing with the environmental projects. We expect to be start working on the Missing Mile section of the canal in March 2024 once planning approval has been secured.</p> <p>The Community Engagement team is building momentum and we have an action-packed set of events and activities lined up for the Canal Spring Festival on 13th & 14th May 2023. This event is being supported by Stonehouse Town Council, corporate sponsors, project partners, organisations and community groups.</p> <p>The main challenge for the project relates to increasing construction and engineering costs and project funding. The £1m additional funding agreed at the S&R Committee Meeting in November 2022 clearly demonstrates SDCs commitment to the successful delivery of the project. We are now working with the project partners to identify and secure the remaining funding required for the project. We will be in a position to pursue and secure the additional funding from National Highways and National Lottery once we have obtained planning approval. We are also working on an active plan to secure funding from Charitable Trusts, Foundations, Public Grants and private donations. We will keep the S&R Committee updated on progress.</p>
