#### 3. Briefly describe its aims and objectives

To provide members of our community and community groups with support and expertise in raising funds for project work, they wish to sponsor, that brings benefit to the wider community. Citizens, businesses, the council, and others can contribute to the fund-raising, as they wish, to meet the funding target set by the sponsors.

The key objectives are as follows:

- Bring community aspirations to life
- Build civic pride
- Increase collaboration

Reduce reliance on Government funding.

#### 5. Who is intended to benefit from it and in what way?

This initiative will potentially benefit both the citizens and the place, depending on the nature of the projects that are sponsored. For example, a community group may setup a project to build a community garden or enable transport in rural areas to improve accessibility.

As stated in the key objectives, this initiative will also have positive impacts for those who take part in the funding campaigns as it will demonstrate to them the power they have to make a positive difference through the initiatives they sponsor and through the collaborative relationships they establish via this work.

#### 6. What outcomes are expected?

A wide range of projects are expected to be funded and then implemented which will enhance and enrich the lives of those who take part in the projects and those who are able to enjoy the outcomes (e.g., in the case of a community garden, other members of the community).

In addition, by providing the on-line platform, access to expertise and match-funding, the relationships between the council and citizens will be improved.

A key outcome is the increase in funding available to community. The council will put money towards projects which align with the council plan priorities and the community will be encouraged to raise funds for themselves. This approach enables the council contribution and the community contribution to increase the amount spent on each project making a positive contribution by increasing the amount available for each project.

By increasing funding and enabling communities to choose their own projects, this works towards building resilient communities.

Community funding is a widely used method for generating funds and is well-referenced including with other local authorities. The council team spoke with Cotswold District Council which has been operating its own initiative for some years and it reported favourable outcomes.
