The main aims of the action plan is to: -

- To invest in identified SDC own play areas based on need and demand.

The current play areas will be subject to a ROSPA (Royal Society of the Prevention of Accidents) inspection which will provide information on the long-term safety of the sites, equipment and ancillary items.

The action plan is aimed at:

- 1. The residents and visitors to the SDC owned play areas.
- 2. To ensure SDC owned play areas are:-
 - Well Designed to encourage play and community cohesion.
 - Well Located near to other community facilities and good pedestrian and cycle networks.
 - **Well Regarded -** the communities value the sites and have ownership of them and are engaged in the redesign and maintenance of the spaces.

6. What outcomes are expected?

The action plan will follow the 4 stages as outlined in the plan:-

- Stage 1 Physical Condition Survey
- Stage 2 Insight
- Stage 3 Identify
- Stage 4 Commitment

This will enable a full analysis on SDC owned play areas to take place to guide the capital investment of £300,000 across the district.
