1. REQUEST FOR DISPENSATION

- **1.1** Councillor Victoria Gray has requested a six month dispensation from attendance at meetings of the authority due to a severe respiratory infection. She is currently unable to attend any meetings..
- **1.2** Section 85 of the Local Government Act 1872 provides that "*if a member of a local authority fails throughout a period of six consecutive months from the date of his last attendance to attend any meeting of the authority, he shall, unless the failure was due to some reason approved by the authority before the expiry of that period, cease to be a member of the authority."*
- **1.3** Councillor Gray last attended a meeting of the authority when she was present at the meeting of the Development Control Committee on 17 January 2023. Section 85(2) of the 1972 Act deems attendance at a meeting of a committee or sub-committee or other council body to be attendance at a meeting of the authority.
- **1.4** Due to health issues, Councillor Gray has not been able to attend a meeting since then and, accordingly, a further dispensation is requested to enable her to remain a member of the Council.

1.5 A dispensation does not preclude Councillor Gray from attending a future meeting during that period should she be well enough to do so.
